- 3. SEA membership operates on an anniversary basis from the date the member first joined. Members will pay fees annually by their anniversary date unless other arrangements have been made for payments with the SEA administrative office. <u>SEA Membership fees are non-refundable and payment plans are annually binding.</u>
- 4. SEA has certified consultants called Authorized Service Providers "ASP" in the implementation of the Lean Enterprise System. The features of the SEA Lean Enterprise System are unique and have been designed to support an industry-wide conversion to lean practices designed to ensure competitiveness for small to mid-size companies. - 5. SEA has certified consultants as Consulting Members. These members have not been certified to implement the SEA Lean Enterprise System but rather have been familiarized with the SEA Roadmap and how to provide services that are compatible and supportive of the SEA Roadmap implementation.
